


# Performance Summary NAPLAN Proficiency







## **Phonics Screening Check**

Each year in term 3, our year 1 students undertake the Department for Education Phonics Screening Check. Students are asked to read a list of 40 words comprising of real words and pseudo words. The year 1 benchmark is a score of 28 out of 40. In 2024, 82% of North Haven School's year 1 students reached benchmark. Their average score was 32 out of 40.



#### **Attendance Comment**

In South Australia, all children and young people must be in school from 6 years to 16 years old. They must attend a government or non-government school full time. From age 16 to 17 however, young people must attend school or an approved learning program (such as an apprenticeship, traineeship, accredited course or university). Schools and parents must encourage and support students to come to school every day. Parents and caregivers must make sure their child is enrolled in a school, and attends school all day and everyday it is open, unless a child is sick or has an approved exemption. Teachers and leaders actively follow up when a student misses school, including recording all absences and non-attendance. All schools in South Australia have local attendance procedures governed under the Education and Children's Services Regulations 2020.
